



- Treat each parent as an individual.
 - Depending on your role, utilize individualized interview questionnaires.
 - Psycho-Social evaluations.

PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Identify specific parental obstacles.

- Poverty
- Substance Abuse
- Mental Health History
- Housing



PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Identify specific resources that will help overcome the identified parental obstacles.

- Community Roundtables
- Collaborative Partner Case Reviews
- Family Group Decision Making



PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Reduce to writing clear expectations for all parties involved.

- Engagement Letters
- Contracts of Expectation
- Execute Commitment Letters
- Family Service Plans

PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Acknowledge the importance of parental bonds and encourage participation in services that strengthen those bonds.

- Family Therapy
- Group Therapy
- Support Groups



PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Identify family generational patterns.

Genograms



PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS? Be aware of your own personal prejudices. Be slow to judge. PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS? Be empathetic. ■ Look at the entire person and not the last worst event. PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS? Be empathetic.

PARENTAL ENGAGEMENT: HOW DO YOU ACCOMPLISH THIS?

Acknowledge the importance of racial and cultural identity.

- Disproportionality
- Disparate treatment

PARENTAL ENGAGEMENT: WHY IS IT IMPORTANT?

- Outcomes for children improve when families are served.
- Permanency for children is obtained faster, when permanency for families is addressed sooner.



PARENTAL ENGAGEMENT: WHY IS IT IMPORTANT?

- **Remember-**
 - The recommendation that you make today not only touches that particular child today, but it touches that child and his/her family for generations to come.
